 - Proposing Clad Bronze Double Hung
 - Installer Vermilion Creek Homes (Dustin)
 - Will need 6 weeks lead time to order windows
 - Wholesale price: \$16,938 (materials) + \$9300 (labor) = \$26,238
 - Anticipated next need to replace windows in 2041. Jerry noted it will be some other Trustee Chair's problem at that time.

 - That the ad board approve cost to replace 20 windows on the southside. Incudes windows, disposal of old windows and installation. Asking for an amount not to exceed \$28,000
 - Jerry Schilling moved and the motion was seconded. Motion was approved.
